- > This warranty is valid in relation to any defect which appears within 2 years from the date of commissioning.

> For Geze Automatic door controls, the Geze Automatic door control warranty is valid from the date of commissioning and it is a requirement that an operator has to be serviced by a qualified and approved GEZE service technician at least once every 12 months or within 500,000 opening cycles, whichever comes first.

## CONDITIONS

Häfele liability under this warranty includes repair or exchange of the goods.

Repairs under this warranty do not extend the warranty period and do not initiate a new warranty period and the warranty period for any replacement parts fitted ends together with the warranty for the entire product.
